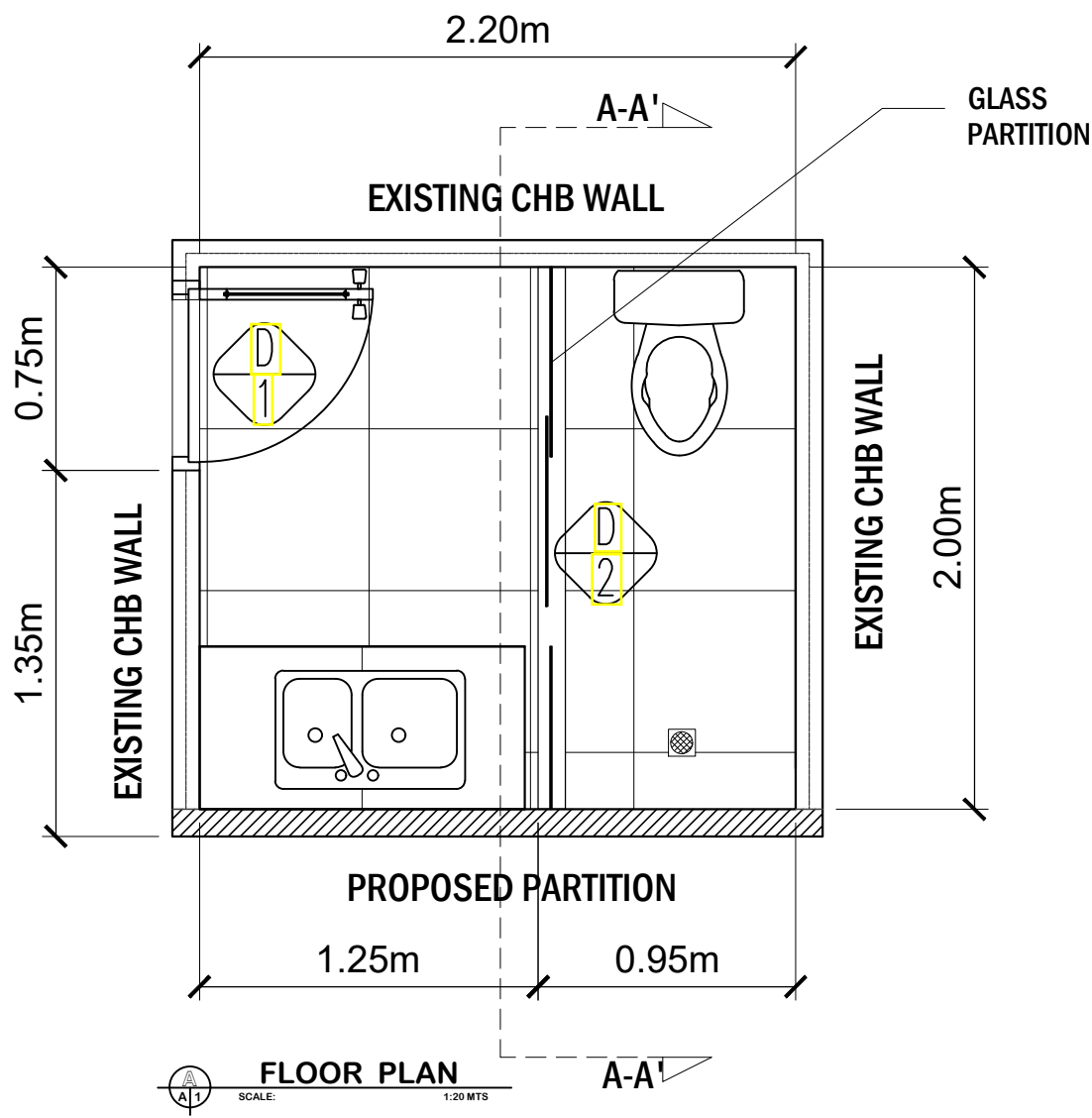

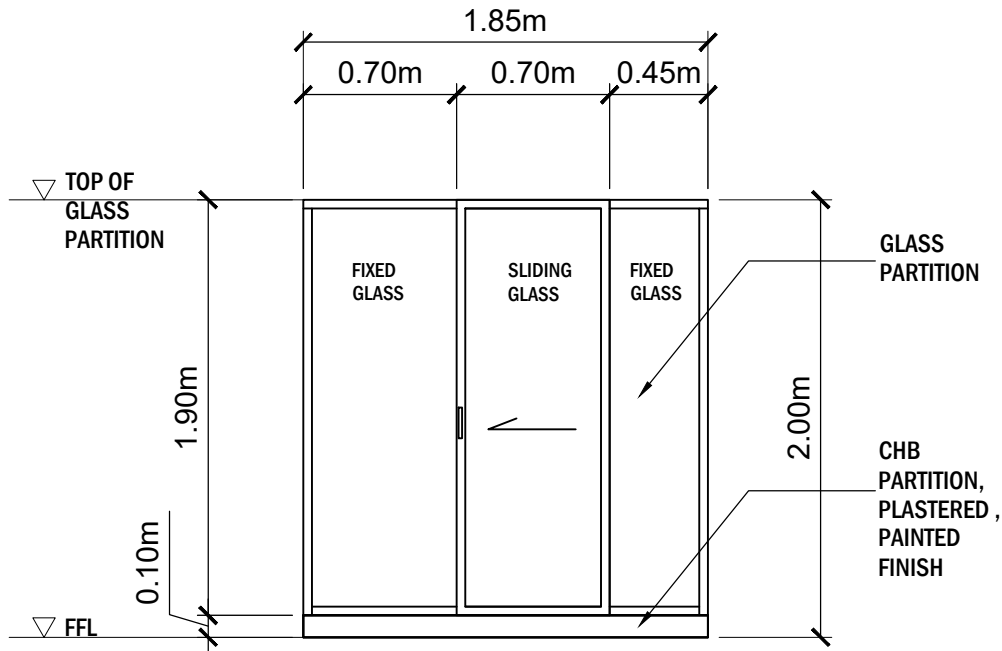
**FLOOR AREA**

PANTRY AREA = 1.25m X 2.00m

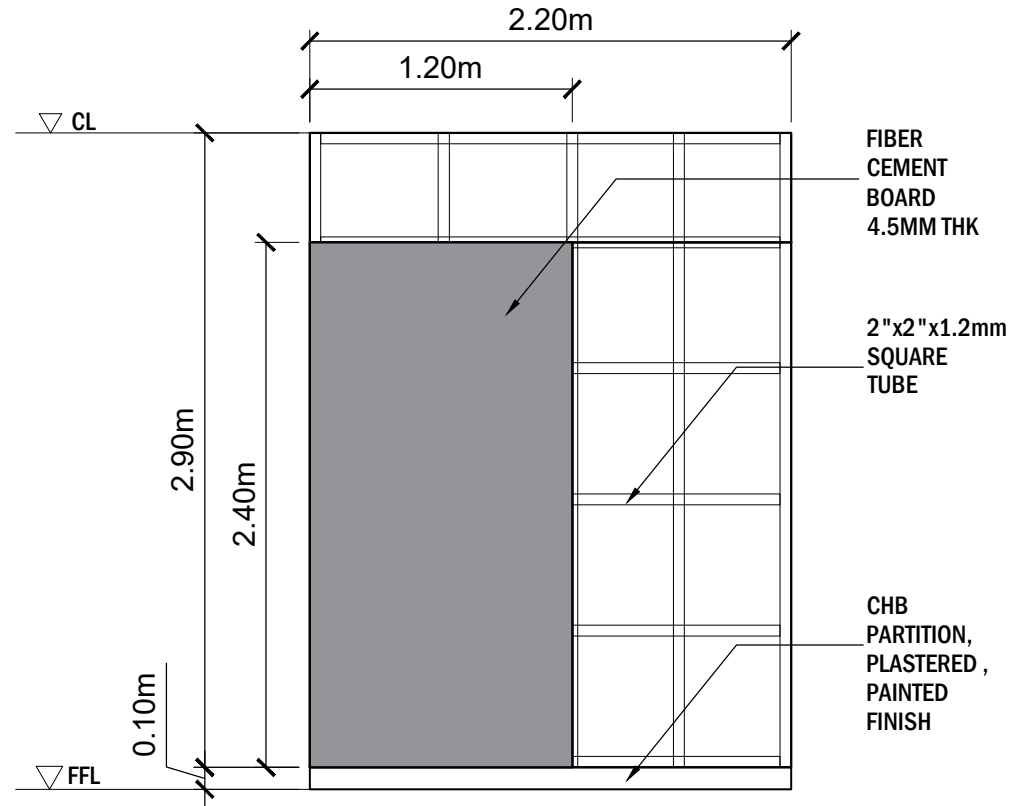

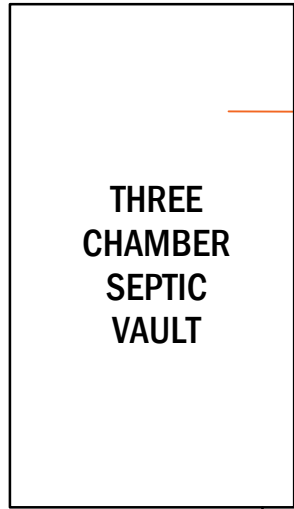
**SECTION THRU A-A'**

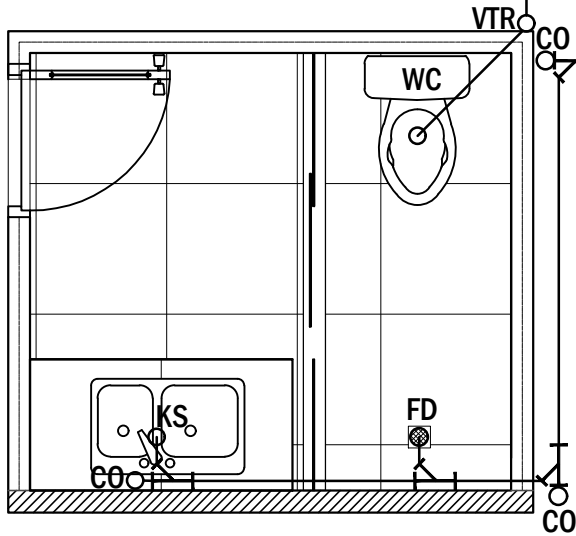

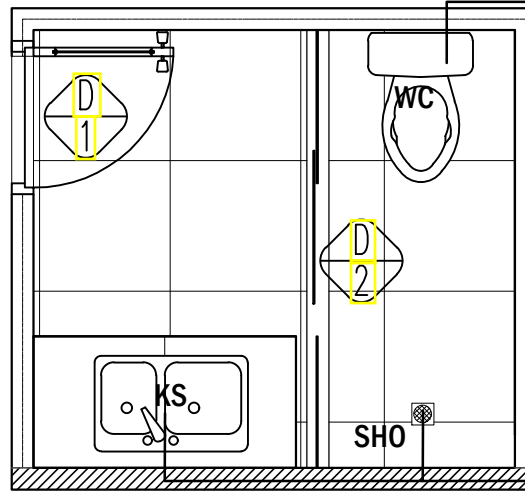


**SANITARY LAY-OUT**
