The final rehearsal will be on February 18, 2025 at Don Mariano Marcos Elementary School. Focal teachers shall ensure that parents' consent is secured prior to the off-campus rehearsals.

The teacher-participant shall adhere to the policy on "No Disruption of Classes" as per DepEd Order No. 9, s. 2005 entitled "Institutionalizing Measures to Increase Engaged Time-on-task and Ensuring Compliance Therewith". School heads are expected to make necessary arrangements ensuring that classes handled by teachers will be taken care of by other teachers.






