**The Philippine Registry of Interpreters for the Deaf, Inc. (PRID)** is thrilled to announce the offering of a scholarship for an online **Sign Language Training Program** in the following **Regions: IV-B, VI, VII, X, XI, XII, XIII and BARRM** where there is a severe shortage or no sign language interpreter at all. PRID is a Sign Language Training institution registered under Securities and Exchange Commission and was established since 1979. Its main objective is to help teachers and other people with the heart to serve Deaf brothers and sisters, including their families, all over the country to have access in essential services like healthcare, education, and legal proceedings which is limited to them due to communication barriers.

PRID teaches integrated sign language and trains a person to interpret for and to communicate with the Deaf. At present, there are 173 active interpreters from PRID all over the Philippines however, there are still severe shortage of sign language interpreters due to limited access to Sign Language Training Program.
