Date : March 28, 2025

Pursuant to Regional Memorandum QAD-2025-030, re: **Monitoring of Private Schools Participating in the Government Assistance and Subsidies (GAS) Programs**, this Office informs private education institutions that Schools Division of Digos City will conduct Monitoring of Private Schools Participating GAS Programs on March 28, 31, and April 2, 2025.

The monitoring activity shall ascertain via physical visit, head count and the like, whether or not the purported participating schools' beneficiaries of Education Service Contracting (ESC) and Senior High School Voucher (SHSVI) programs are legitimate GASTPE recipients vis-à-vis the Private Education Assistance Committee's (PEAC) official list.

Further, SDOs are required to report other GASTPE program violations such as but not limited to; the inclusion of learners who are non-GASTPE beneficiaries, misrepresentation of a legitimate GASTPE-beneficiary, etc. using the attached standardized reporting template.

It shall be the responsibility of the Private Schools Focal to coordinate with PEAC XI with respect to the list of GASTPE recipients and with their respective participating private schools with respect to the monitoring activity.

MONITORING OF PRIVATE SCHOOLS PARTICIPATING IN THE GOVERNMENT ASSISTANCE AND SUBSIDIES (GAS) PROGRAMS

To: Assistant Regional Director
Schools Division Superintendents

1. Pursuant to **DepED Order 88, s. 2010 or the 2011 Manual of Regulations for Private Schools in Basic Education**, all private educational institutions shall be subject to reasonable supervision and regulation by the Department of Education. In relation to this, DepED reiterates the authority of DepED Regional Offices and Schools Division Offices to oversee the performance and compliance of Government Assistance to Students and Teachers in Private Education (GASTPE) participating schools.
2. In view hereof, Schools Division Offices (SDOs) are directed to submit monitoring reports of their GASTPE participating schools using the attached standardized reporting template.
3. The monitoring activity shall ascertain via physical visit, head count and the like, whether or not the purported participating schools' beneficiaries of Education Service Contracting (ESC) and Senior High School Voucher (SHS) programs are legitimate GASTPE recipients vis-à-vis the Private Education Assistance Committee's (PEAC) official list.
4. Further, SDOs are required to report other GASTPE program violations such as but not limited to; the inclusion of learners who are non-GASTPE beneficiaries, misrepresentation of a legitimate GASTPE beneficiary, etc.
5. It shall be the responsibility of the SDOs to coordinate with PEAC XI with respect to the list of GASTPE recipients and with their respective participating private schools with respect to the monitoring activity.
