1. Clarification on the Technical Specifications of Banana Chips:

<b>Requirement for Suppliers</b>  7. If the product/item is defective/damaged the supplier will replace the damaged product. 8. Staggered payment once distribution is started (after 20 days delivery).	<b>7. Supplier shall provide replacement in case, during delivery, NFP item/s is/are found defective/damaged in packaging, or due to presence of insects, molds, and other conditions which are not normal of said products. Hence, the supplier must bring extra items which shall serve as 'buffer' items for its immediate replacement in case of defects or damages.</b> <b>8. For payment, progress billing is considered after 50% delivery of NFP.</b> <b>9. The Supplier should at least have a License to Operate (LTO) issued by the Food and Drug Administration (FDA).</b>

Supplier shall provide replacement in case, during delivery, NFP item/s is/are found defective/damaged/cracked, or items have undesirable smell, and other conditions which are not normal of said items. Hence, the supplier must bring extra items which shall serve as 'buffer' items for its immediate replacement in case of defects or damages.</b> <b>7. For payment, progress billing is considered after 50% delivery of NFP.</b>
