1. Deworming is an essential component of the School-Based Feeding Program (SBFP), by incorporating the deworming into the SBFP; the program can have a more significant impact on health, nutrition and education of beneficiary children.
2. The outcomes of this activity are the following:
 - a. Improved Nutrition outcomes
 - b. Enhanced Cognitive Function
 - c. Improved School Attendance
 - d. Reduced Morbidity and Mortality Rate due to Anemia and hookworm diseases
 - e. Increased productivity
 - f. Fast absorption of food intake and reduce School-Based Feeding Program (SBFP) negated
3. In connection to the above mentioned; the field is hereby informed that the School-Based Feeding Program beneficiaries are recommended to take deworming drugs on April 08-11, 2025
4. The feeding beneficiaries must be fed before administering the deworming drugs.
5. No parents Consent, No deworming drugs Administration should be observed

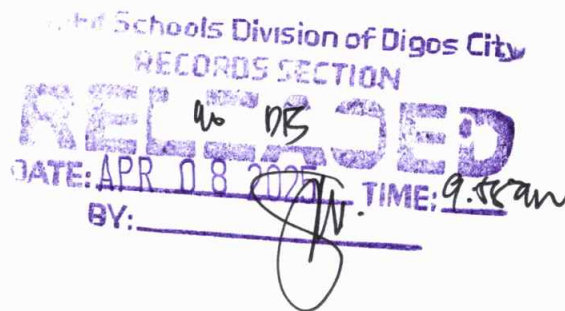
