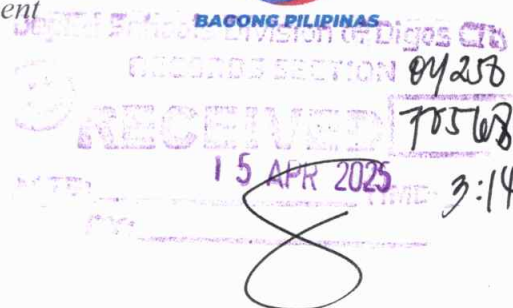


Dear Ma'am Estacio,
