- List of students per grade level;
- List of least mastered competencies per learner;
- List of learning areas/to be offered per grade level;
- List of teachers and subjects they will teach;
- Class program; and
- Parent's consent

Private schools shall implement the guidelines stipulated in DM 35, s. 2025 entitled: Supplemental Guidelines for the Implementation of the Summer Academic Remedial Program (SARP).

Learning assessment for SARP shall be in accordance with DO 8, s. 2015, including the computation of grades.
