In preparation for the opening of classes for School Year 2025-2026, all ALS Teachers and Community ALS Implementers are hereby directed to conduct **Literacy Mapping of Potential ALS Learners** in 26 Barangays within Digos City from **June 2-6 and 9-13, 2025** with the assistance of the Division ALS Focal Person and Education Program Specialist II in ALS.

The activity aims to:

- Gather accurate data on the literacy levels of out-of-school youth, children and adults (OSYCA) as potential ALS learners in each Barangay.
- Track and update the record of ALS Passers.
- Enroll and cater to interested learners for SY 2025-2026.

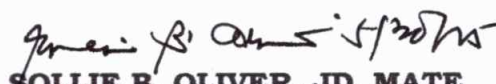
