

The Department of Education (DepEd) through the Bureau of Learners Support Services- School Health Division (BLSS-SHD) continues to implement the School – Based Feeding Program (SBFP) nationwide in accordance with the Republic Act No. 12116, General Appropriations Act (GAA) for FY 2025 and in compliance with Republic Act. No. 11037 “Masustansyang Pagkain para sa Batang Pilipino Act” RA 11037 was signed by the President Rodrigo R. Duterte on June 2018, and constitutes the primary statutory basis for the implementation of SBFP. The law aims to implement programs that sustain and improve the health and nutrition of school children through the SBFP.
2. To strengthen the School-Based Feeding Program implementation during summer class the field is hereby informed of the re: **Virtual Consultation on School-Based Feeding Program Summer Class Implementation** on May 19, 2025 at 1:30pm, the link will be posted at the Health School Administrators group chat.

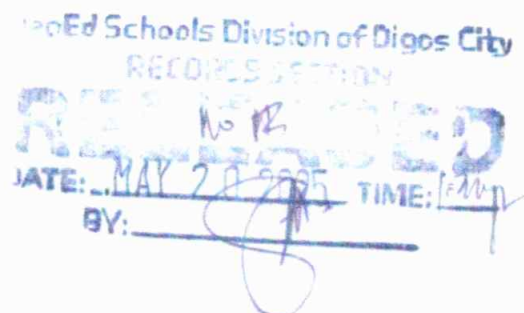
