Date : June 2, 2025

Proper management of learning resources and educational assets is key to ensuring accurate reporting and maximizing educational outcomes division-wide.

The Learning Resource Management Section (LRMS) will conduct a **pilot test** of the **Division Resource and Educational Asset Management System (DREAMS)** on June 5, 2025, at a selected school from 8:00 am to 5:00 pm. The objectives are:

- a. Test Data Entry Accuracy: Verify the accuracy of the data entry interface for schools.
- b. Visual Dashboard Evaluation: Assess the visual dashboard's display of updates on resource availability, utilization, and gaps.
- c. Device Compatibility: Test the system's interaction with mobile devices and other devices.
- d. Report Generation: Check if the system can generate reports on resource availability, utilization rates, and trends without delay.
- e. Data Security: Evaluate user roles, permissions, and protection of sensitive data.
- f. Data Backup: Ensure regular backup of all data to prevent loss in case of technical issues.
