In reference to the 2nd Indorsement dated April 22, 2025, signed by Director Allan G. Farnazo, Director IV of the DepEd Regional Office XI, this Office hereby informs the field of the **closure of Cavity Bible Baptist Academy – Digos Branch (hereafter referred to as CBBA – Digos Branch)** for School Year 2024–2025.

The closure is due to the following clear violations of the provisions of the 2011 Manual of Regulations for Private Schools in Basic Education, Batas Pambansa Blg. 232 (Education Act of 1982), and other relevant laws and regulations:

- (1) Absence of school site and physical structures;
- (2) Non-compliance with the DepEd prescribed curriculum; and
- (3) No learners for the face-to-face classes.

The Division Information Officer, Dr. Leilani T. Señires, Education Program Supervisor is requested to publish the closure of the above-mentioned school in the DepEd Digos City Facebook Page.

Respectfully referred to **Melanie P. Estacio, Schools Division Superintendent, DepEd Digos City**, the herein communication recommending the closure of Cavite Bible Baptist Academy-Digos City Branch (**CBBA – Digos Branch for brevity**) for School Year 2024-2025 due to the following patent violations to the provisions of the 2011 Manual of Regulations for Private Schools in Basic Education, Batas Pambansa Blg. 232 (Education Act of 1982) and other existing laws (1) absence of school site and physical structures; (2) non-compliance with the DepED prescribed curriculum; and (3) no learners for the face-to-face classes.

This Office finds merit to the aforementioned recommendation and hereby approves the closure of Cavite Bible Baptist Academy-Digos Branch for School Year 2024-2025.

Further, this Office confirms the non-compliance of CBBA-Digos Branch to the documented agreements inked together and between with DepED Regional Office XI and DepED Digos City Division.

The documented agreements (copies are attached) centers on the smooth transfer of students to the public schools and the submission of learners' credentials and vital information to DepED Digos City.

However, despite the assistance, understanding and chances provided to the institution, the same is deliberate in its non-compliance to the documented agreements, putting the education of the affected learners at great risk.

That Schools Division Office is directed to exhaust all means to ensure that this information be conveyed to the concerned institution, through its duly constituted authority.
