COMPLIANCE TO DEPED ORDER NO. 15, S. 2025 TO ALL PUBLIC AND PRIVATE SCHOOLS OFFERING KINDERGARTEN EDUCATION

To: Assistant Regional Director Schools Division Superintendents

- Pursuant to DepEd Order No. 15, s. 2025, titled "Amendment to DepEd Order No. 47, s. 2016 as Amended by DepEd Order No. 020, s. 2018", this Office reiterates the strict compliance of all public and private schools offering Kindergarten Education on the implementation of the revised enrollment procedures.
- Paragraph 15-A, Section VI of the DepEd Order states children who will be five years old by October 31 of the school year they are enrolling in shall be accepted in Kindergarten. Schools may accept late enrollees beyond this cut-off date only if the child has completed Early Childhood Education (ECE) programs recognized by the Department of Education and subject to readiness assessment.
- For further clarifications, please refer to RM CLMD-2025-301 on the FAQs about Kindergarten Education and Enrollment Guidelines aligned with RA 10157, RA 10533, and current DepEd Orders for SY 2025-2026. This should be prominently posted in schools and widely shared with all stakeholders, especially parents and guardians.
