The Department of Education (DepEd) officially partnered with the Securities and Exchange Commission (SEC) on October 9, 2024, to launch **SEC Communication, Advocacy, and Network Initiative (SEC CANI)**. This pioneering pilot program is designed to boost financial literacy and greater participation in the capital markets. Through SEC CANI, the SEC provides informative trainings and webinars on key topics such as personal finance management, investment fundamentals for beginners, and effective debt management strategies.

To maximize the benefits of this important partnership, all Regional Directors are strongly encouraged to develop and/or integrate in their existing teacher welfare program and actively engage/coordinate with the nearest SEC Extension Offices (*Annex A: Directory*) in implementing financial empowerment initiatives under SEC CANI. These initiatives are designed to support all teaching, related-teaching, and non-teaching personnel by providing them with:

- comprehensive financial education sessions;
- practical guidance on investment opportunities; and
- tools and strategies for responsible debt management
