President Ferdinand R. Marcos, Jr. has declared every July 17–23 of every year as the **National Disability Rights Week (NDRW) Celebration** through Proclamation No. 597. He repealed Proclamation No. 361, which had previously been designated as "National Disability Prevention and Rehabilitation (NDPR) Week." This is to ensure full and equal enjoyment of all human rights and freedoms, emphasizing the Philippines' dedication to the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) goal of promoting, protecting, and ensuring the rights and dignity of persons with disabilities.

The Proclamation No. 597 directed all government agencies and instrumentalities, including government-owned or controlled corporations, state universities, and colleges, to observe the celebration. All local government units, non-government organizations, and private sectors are encouraged to observe the same. This year's 47th NDRW celebration theme is "Innovation for Inclusion: Building Inclusive Communities Together".
