All participants are hereby advised to report to the training venues at **5:30 PM** on the first day of the training for settling-in, registration, and opening program.



1. The Boy Scouts of the Philippines – Davao del Sur Council will conduct a series of YOUTH LEADERS TRAINING COURSES and are scheduled as follows:

2. A Registration Fee of **P600.00** shall be collected from each participant to cover the expenses incurred during the training which includes handouts, admin materials, and souvenir T-shirt.
3. Participant must be currently registered as a Boy Scout for PLTC and Senior Scout for CLTC with the Boy Scouts of the Philippines and must be physically and mentally fit and possess good moral character. Likewise, participants are encouraged to bring their own Type "A" or "B" Scout Uniform, or Senior Scout Neckerchief, food for the whole duration of the training, sleeping gear, toiletries, and other personal necessities.
4. All participants are hereby advised to report at the training venues on or before **5:30 PM** on the first day of the training for settling-in, registration, and opening program.
5. To exercise effective and efficient training management, a ratio of one (1) Adult Leader for every nine (9) Scouts (1:9) must be observed. Corresponding service credits may be granted to all accompanying Adult Leaders as provided for by DepEd Order No. 76, s. 2012 once necessary documents are found to be in order.
