All participants are hereby advised to report at the training venues on or before 5:30 PM on the first day of the training for settling-in, registration, and opening program.

Corresponding compensatory overtime credit (COC) shall be granted for the service rendered on Saturday and Sunday as stipulated in DepEd Order No. 013, s. 2024 once necessary documents are found to be in order.
