Schools with reported LRP-related incidents are advised to be ready with reports on handling the cases and provisions of appropriate services, including the means of verification of the CPC functionality indicators which the monitoring aims to assess in the following areas:

- A. Organization and Coordination;
- B. Policies and Guidelines;
- C. Capacities and Resources;
- D. Service Delivery; and
- E. Accountability and Performance.

Monitoring tool on the CPC Functionality is enclosed in the Regional Memorandum No. ESSD-2025-129 dated April 30, 2025. The Regional Monitoring team shall furnish the Top Management the results of the field monitoring including recommendations and actions to be undertaken.



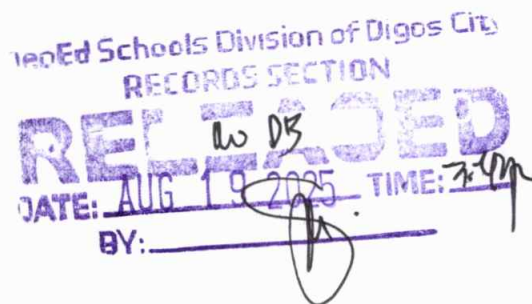

**JOINT REGIONAL MONITORING ON OPLAN KALUSUGAN SA DEPED FLAGSHIP  
PROGRAMS AND LEARNER RIGHTS AND PROTECTION PROGRAM**

To: Schools Division Superintendents

1. Pursuant to Regional Memorandum No. ESSD-2025-196 dated July 10, 2025, the Regional Office through the Education Support Services Division will conduct Joint Monitoring on Oplan Kalusugan sa DepEd (OKD) Flagship Programs and Learner Rights and Protection Program (LRP). This is crucial in harmonizing implementation of Learner Rights and Protection Program with the provision of services and enhancement of health systems in providing appropriate response and resources on handling and referral of LRP-related cases.

- Capacities and Resources;
- Service Delivery; and
- Accountability and Performance.

4. Monitoring tool on the CPC Functionality is enclosed in Regional Memorandum No. ESSD-2025-129 dated April 30, 2025, entitled "Submission of Results of the Child Protection Committee Functionality Assessment Tool."

5. The team shall furnish the top management the results of the field monitoring including recommendations and actions to be undertaken.

6. Travelling, incidental, and other expenses shall be charged against local funds or LRP Program Support Funds subject to the usual accounting and auditing rules and regulations.
