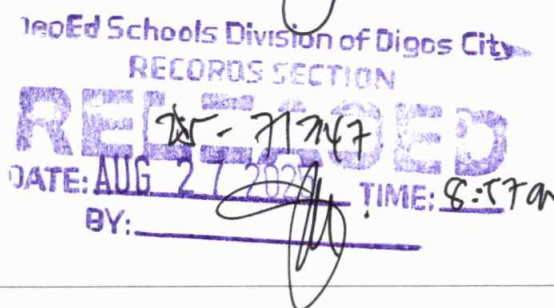

SUBJECT : **CONDUCT OF SPECIAL CONSULTATIVE CONFERENCE**  
**WITH REGIONAL ALS FOCAL PERSONS**

DATE : August 4, 2025

The Bureau of Alternative Education (BAE) will conduct a *Special Consultative Conference with Regional ALS Focal Persons on August 15, 2025 (exclusive of travel time), in National Capital Region (NCR)*. The specific venue will be announced through a separate issuance.

This conference aims to serve as a platform for dialogue and consultation on key operational matters related to the implementation of the Alternative Learning System (ALS), particularly on the following topics:

- a. Opening of ALS classes for School Year 2025–2026;
- b. Status of ALS enrollment;
- c. Results of the Learning Enhancement Program;
- d. 2024 ALS Accreditation and Equivalency (A&E) Test Results;
- e. Status of funds for the provision of furniture and fixtures for the eight (8) newly constructed School-Based Learning Centers (SBLCs) for ALS;
- f. Downloading of funds for the payment of Transportation and Teaching Aid (TTA) allowance for ALS teachers and other Program Support Funds; and
- g. Issues and challenges encountered by the regions in the implementation of ALS programs, with the goal of identifying appropriate and feasible solutions.

To guide the discussions, all Regional ALS Focal Persons are requested to submit a 3–5 minute video presentation addressing the following points: a) factors affecting high or low enrollment for the current school year, b) strategies implemented or planned to boost enrollment, c) specific support needed from BAE to strengthen ALS program implementation in their respective regions, and d) utilization rate of downloaded funds (Program Support Funds, and payment of Transportation and Teaching Aid (TTA) allowance for ALS Teachers). A template for the required data will be sent to your respective email addresses.
