Compensatory time-off credits will be granted to non-teaching personnel in accordance with Civil Service Commission (CSC) Resolution No. 98-404 and Memorandum Circular No. 41, s. 1998, which outline the guidelines for the use of compensatory time-off for services rendered beyond regular working hours. Travel, meals, accommodation and other relevant incidental expenses incurred by the participants shall be charged against local funds / MOOE subject to the usual accounting and auditing rules and regulations.
