REITERATION OF THE POLICY ON PROVISION OF INTERVENTION TO LEARNERS

To: Assistant Regional Director  
 Schools Division Superintendents  
 Chief Education Supervisor, CLMD

- To immediately address learning gaps, this Office reiterates the Policy on the Provision of Intervention to Learners as stipulated in DepEd Order 8, s. 2015 Policy Guidelines on Classroom Assessment for the K to 12 Basic Education Program.
- The Order provides that when a learner's raw scores are consistently below expectations in Written Work and Performance Tasks, the parents or guardians must be informed not later than the **fifth week of that quarter**. This will enable them to help and guide the learners to improve and prepare for the Quarterly Assessment. A learner who receives a grade below 75 in any subject in quarter must be given intervention through remediation and extra lessons from the teacher/s of the subject.
- The beginning and end of each quarter for SY 2025-2026 are hereby extracted as per DO 012, s. 2025 Multi-Year Implementing Guidelines on the School Calendar and Activities.

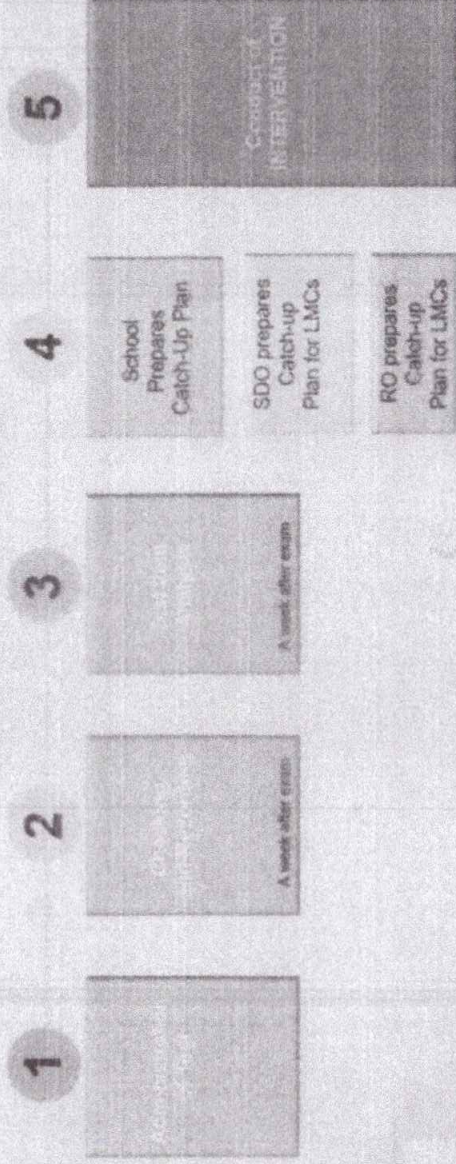
