The P887 Constitution emphasizes the value of the dignity of every human person, and guarantees full respect for human rights. Moreover, Section 2 of the Safe Spaces Act. (SSA) underscores the policy of the State to recognize that both men and women must have equality, security and safety not only in private, but also on the streets, public spaces, online, workplaces and educational training institutions. The implementing Rules and Regulations (IRR) of the SSA further mandates the Department of Education (DepEd) to conduct orientations on the law and its rules, and trainings on gender sensitivity, gender-based violence, sexual orientation, gender identity and expression (SOGIE), and other gender and development (GAD) topics.

In compliance with the foregoing constitutional and statisficy mandates, the Office of the Director for Legal Service (ODLS) of DepEd. Central Office (CO), in collaboration with its partners and stakeholders, intends to strengthen the legal arm of DepEd through the conduct of cipacity-building training of legal officers and lawyers, in the CO and field offices, handling cases of sexual harassment and gender based sexual harassment. This training aims to improve the delivery of legal service of DepEd by educating and equipping the participants with the necessary knowledge and expertise on the SSA and related case and statutory laws, and the compliance of DepEd and its schools particularly on the constitution of the Committee on Decorum and Investigation (CODI). Accordingly, the ODLS mends to conduct a comprehensive training on the following

- Republic Act No. 11313 or the Safe Spaces Act and its IRP
- 2. Case and statutory laws in relation to the SSA and its IRR, and
- Sexual Orientation Gender Identity, and Gender Expression (SOGIE) and Gender and Development (GAD).
