

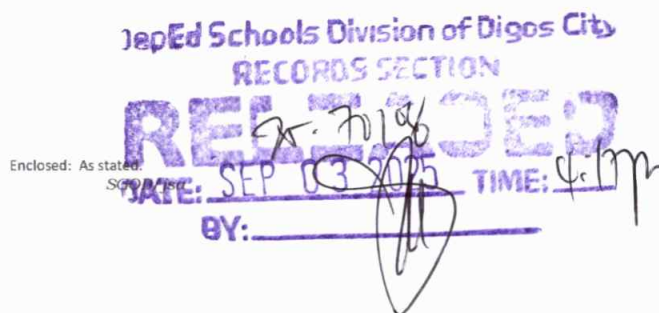

Greetings!

We are reaching out to request your department's cooperation by providing us data and information to review the 30-year implementation of the Philippine Plan for Gender Responsive Development 1995-2025 (PPGD), which is ending this year. The result of this assessment will feed into the development of a successor long-term plan on gender equality and women's empowerment and the Philippine's 2030 report on gender in the Sustainable Development Goals.

We have enclosed a questionnaire to guide your Gender and Development (GAD) Focal Point System, and other relevant units of your department, in preparing the needed inputs.

The implementation of the Philippine Plan for Gender Responsive Development 1995-2025 is now being assessed to determine the extent to which the targeted general and sectoral outcomes of the Plan have been achieved. The assessment of the PPGD includes the extent to which the subsequent time-slice plans (i.e., Framework Plan for Women 2001-2004, Women's Empowerment and Gender Equality Plan 2013-2016; and Updated Gender Equality and Women Empowerment Plan 2019-2025) have been implemented, and their target outcomes, which carried out the target outcomes of the PPGD, have been realized. Qualitative data for the assessment will come from the stakeholders and from research, while quantitative data will come from official statistics and from the sex disaggregated data of partner agencies. Consultation workshops with regional agencies, LGUs and NGOs will also be conducted to obtain ground-level information and recommendations and to further substantiate and validate the findings.


