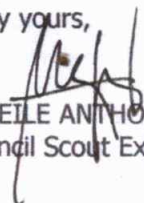

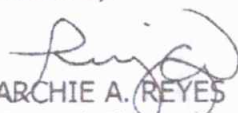
Attire: Casual Attire with Adult Neckerchief (Type "C" Uniform)
