Dear Ma'am:

In line with the upcoming Provincial Evaluation of "Gulayan sa Probinsya: Search for Best School and Barangay, and Gulayan sa Bakuran sa mga Barangay Relocation Sites Garden Implementers CY 2025," scheduled on October 27—November 7, 2025, this activity forms part of the major flagship programs of the Provincial Government of Davao del Sur under the dynamic leadership of Governor Yvonne Roña Cagas through the I-HELP I-SHARE +++ agenda. The program primarily engages DepEd Provincial and City Division Schools, Barangays, and Barangay Relocation Sites, which have been capacitated through continuous development initiatives. It aims to promote the production of healthy, safe, and quality vegetables; ensure sufficient supply for school and household consumption; support supplementary feeding; alleviate malnutrition and poverty; and provide additional income opportunities, particularly for marginalized families.

Following are the significant excerpts of approved guidelines during the *Provincial/City/Municipal Evaluators Meeting on October 10, 2025 held at OPAG-Training Center,* to wit:

- Municipal/City/OPAG Evaluation Team Composition will be composed of representatives from MAGrO/CAgrO/OPAG (Chairman), DepEd (Vice Chairman), MSWDO/CSWDO/PSWDO (Member), MHO/CHO/PHO (Member), and DILG (Member) as stipulated on GPP Implementing Guidelines and MOA between DA and DepEd;
- Conduct of Municipal/City Evaluation, prior the evaluation there should have a Meeting/FGD with the Members of the Evaluation Team of which members are particularly identified above and strictly imposed on their respective Evaluation Schedule;
 - 2.a Initiate an option/strategy to have a Pre Evaluation in order to facilitate the conduct of the Municipal/City Evaluation & submission of its Final Entries per Municipality/City at OPAg and/or DepEd District Offices of Provincial/City Divisions Schools;
 - 2.b Municipal/City Final Entry Results Submission on or before November 27, 2025 (submission thru text/chat via SMS or Messenger or advance Ecopy send to: opaghcvdpdavaodelsur@gmail.com & ferdinandcrispino88@gmail.com will be accommodated; & hard copy will follow with proper transmittal/endorsement at OPAg HVCDP. Following are the possible Entry Winners per LGU, to wit:

- i. One (1) Entry on Field Garden each for Elementary School & One National High School;
- ii. One (1) Entry on Container Garden each for Elementary School & National High School;
- iii. One (1) Barangay Entry on Field Garden per LGU;
- iv. One (1) Barangay Entry on Container Garden per LGU;
- v. One (1) Barangay Entry on BRS Field/Container Garden per LGU;
- 2.c Provincial Evaluation to all City/Municipal Entry Winners (Schools, BLGUs, & BRS) shall commence immediately after the submission of the above results on set deadline. City/Municipal HVCDP Coordinators and/or District/School GPP Coordinators are encouraged to submit their respective results as scheduled since the Provincial Evaluators Team shall be considering of forfeiting the late submitted entries to avoid disruption of evaluation schedules;
- 2.d Awarding Ceremony of "Gulayan sa Probinsya: Search for Best Schools & Barangay, & Gulayan sa Bakuran sa mga Barangay Relocation Sites Garden Implementers CY 2025" will be on December this year. After the Final Evaluators Rating and Deliberation, the program coordinator will inform the potential achievers/winners thru the assistance of concerned Provincial and City Divisions Schools GPP Program Coordinators and City/MAGrO HVCDP Coordinators to facilitate its dissemination of Final Results.
- 3. Evaluators Team Member consistency during the conduct of Evaluation from the beginning until the last day is strictly observed by the City/Municipal/Provincial Evaluators. For some reason(s) due to inevitable event(s) which might cause the absence of any Evaluator during the evaluation has been approved by the Evaluators of which all the Entry Schools, BLGUs and BRS should provide the necessary documentations (scrap books and video presentations) as basis for review during the Final Rating and Deliberation.
- 4. Provincial Evaluations Schedules for Schools, Barangays and Barangay Relocation Sites, to wit:
