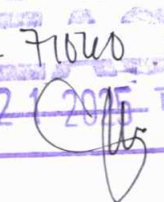
The list of participants and details of the event are found in the enclosures.

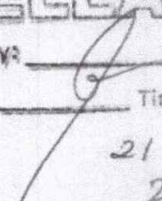
