#### Competition

- Modality: To be held onsite in the Ateneo de Manila University, Katipunan Avenue, Quezon City
- Divisions: The whole competition will consist of three [3] different divisions
  - 1. Grade School Division (Grades 4-6)
  - 2. Junior High School Division (Grades 7-10)
  - 3. Senior High School Division (Grades 11-12)
- Stages: Every division will have three (3) rounds:
  - 1. Written Elimination Round
  - 2. Oral Semi-Final Round
  - 3. Oral Final Round
- Registration:
  - Early Registration Fee (November 17 to November 28, 2025):
    - PHP 1,000 / team (Private Schools)
    - PHP 850 / team (Public or Science Schools)
  - Regular Registration Fee (November 29 to December 5, 2025):
    - PHP 1,250 / team (Private Schools)
    - PHP 1,100 / team (Public or Science Schools)
  - Discount, for teams that have all members attending the workshops:
    - Less PHP 200 / team (Private Schools)
    - Less PHP 250 / team (Public or Science Schools)
  - o Each school may enter a maximum of three (3) teams per division, with each team composed of three (3) students.


## Workshop


- 1-day workshop that is only open for Grade School and Junior High School students. This may serve as their preparation for the competition.

  - There is no limit to the number of attendees per division.






