COLLABORATIVE AND CONSULTATIVE ACTIVITY: BAYANIHAN SA PAGPAPATITULO NG MGA PAARALAN FOR THE DIVISION OF DAVAO DEL SUR, DIGOS CITY AND DAVAO CITY

- 1. In line with the Department of Education's continuing mandate to ensure equitable access to quality basic education and, in particular, its imperative to safeguard the Department's proprietary interest in public school sites, this Office, through the thrust of the Legal Unit and the Sites Titling Office (STO), will conduct a **BAYANIHAN SA PAGPAPATITULO NG MGA PAARALAN** for the Divisions of Davao Del Sur, Digos City and Davao City on **November 23-26**, **2025** at **The Ritz Hotel at Garden Oases**, Porras St., Bo. Obrero, Davao City. This activity forms part of the Division's strengthened implementation of the **School-Site Institutional Guidance on Registration and Documentation (S.I.G.U.R.A.D.O.)** Activity, which seeks to ensure that all school sites within the Province of Davao del Sur are properly documented, safeguarded, and supported through unified legal and technical processes.
- 2. The **BAYANIHAN SA PAGPAPATITULO NG MGA PAARALAN** is a collaborative pro bono initiative led by **Atty. Blake S. Feken** and his team from **RealtyPro & Diligence, Inc.**, in partnership with the **DepEd Sites Titling Office (Central Office)**. The activity underscores the spirit of *bayanihan* in addressing long-standing issues in school site titling by promoting coordination between the Central and Division Offices, consolidating documentary gaps, and identifying practical legal and technical solutions to expedite the titling process.
- 3. The activity will gather concerned school heads from the Divisions of Davao del Sur, Digos City, and Davao City, particularly those with **schools facing complex land ownership or titling concerns**. It will serve as a joint validation and consultation

session on school site documentation and titling matters, providing an avenue for participants to present issues, review documents, and receive guidance from experts and partner agencies.

- 4. This program is conducted in batches across provinces in the country to foster shared responsibility among government agencies and education stakeholders. It equips participants with the knowledge and tools necessary to sustainably address school site titling issues and to ensure the protection and legal ownership of public school properties.
- 5. Identified school heads or their lawful representatives who have knowledge of the titling status of their schools are directed to attend the above-mentioned activity. See attached enclosure for the list of identified schools and participation details.
