TRAINING FOR TECHNICAL OFFICIALS (TOs) AND COACHES ON WEIGHTLIFTING

To: Schools Division Superintendents

1. This Office, through the Education Support Services Division (ESSD), will conduct **Training for Technical Officials (TOs) and Coaches on Weightlifting** on **November 11-13, 2025** at **A. Mabini Elementary School, Davao City**.
2. Each SDO is hereby required to submit two recommended participants for Technical Officials (TOs) and two Coaches on Weightlifting, on or before October 31, 2025.
3. Recommended TOs must be below 52 years old and are physically fit to manage and officiate weightlifting competitions.
4. Travel expenses of participants shall be charged to local funds subject to the usual accounting rules and regulations, while food shall be charged to the remaining downloaded funds for sports. First meal to be served will be dinner on (Day 0), November 10, 2025, and the last meal is afternoon snacks on November 13, 2025. Accommodation, including beddings, will be provided for the participants.
