In this connection, the National Educators Academy of the Philippines (NEAP) hereby requests the Regional Offices (ROs) to endorse one (1) qualified teacher, teaching-related personnel, or school leader nominee with complete and clearly scanned documents (refer to Annex A) on or before **05 December 2025** through <https://forms.office.com/r/Z13HQghaTG>.
5. For initial screening purposes and shortlisting, the following screening criteria, aligned with the eligibility requirements outlined in Annex A, shall be applied. These criteria do not entail additional documentary submissions:
 - a. Meets the age, length-of-service, and employment-status requirements specified in Annex A;
 - b. Holds a bachelor's degree or possesses relevant experience aligned with the chosen program;
 - c. Has obtained a Very Satisfactory (VS) or Outstanding performance rating for the last two (2) evaluation period;
 - d. Has no pending administrative or criminal cases, as certified through documents required under Annex A;
 - e. Is formally endorsed by the Head of Office (SDS for SDOs and RD for ROs);
 - f. Commits to render the required return service to DepEd upon completion of the program;
 - g. Is physically and mentally fit, supported by a medical certificate included in the application;
 - h. Has no outstanding scholarship obligations, as evidenced by the Scholarship Clearance required under Annex A; and
 - i. Submits all documentary and eligibility requirements prescribed by **CHED/KOICA, as listed in Annex A.**
6. Kindly note that only those nominees with complete documentation shall be processed and endorsed by NEAP to CHED IAS and KOICA.
7. Qualified nominees shall subsequently undergo selection procedures prescribed by the accepting/hosting university and KOICA, including document screening, online panel interviews, technical interviews (if applicable), and final interviews by the selection committee.

A. QUALIFICATION REQUIREMENTS

1. Philippine Government

- a. Must be 40 years old and below provided the return service obligation is still within the nominee's serviceable years;
- b. Candidate must have rendered at least two (2) years of service;
- c. Must hold a permanent appointment;
- d. Must have a college degree related to the field of study or has sufficient demonstrated ability and experience along the field of study;
- e. Must not have a pending application for scholarship under another program; and
- f. Must have rendered the service obligation required under Executive Order 367 for scholarship recently concluded before he/she could again be nominated for another program where the field of study is different from the previous training.

 - a. That the nominee has no pending administrative and criminal charges;
 - b. That the nominee has been conferred with a degree; and

- c. Assurance of utilizing the services of the nominee, if accepted for a period of not less than two (2) years of every year of scholarship or a fraction thereof not less than six (6) months or as provided under E.O. 367 amending E.O. 129

3. Certified Copy of Statement of Actual Duties and Responsibilities
4. Certified True Copy of Transcript of Academic Records (Baccalaureate and Graduate, if applicable)
5. Certified True Copy of Diploma
6. Certification that the nominee has no pending administrative and criminal case
7. Certification that the nominee has no pending scholarship nomination to other program(s)
8. Updated biodata/resume with list of in-service training and seminars attended (spell out acronyms of organizers and topics or subjects of the training programs); certificates of training **NEED NOT** be submitted)
