The Supplier/Service Provider with the Single/Lowest Calculated Quotation shall submit its **Omnibus Sworn Statement (GPPB-prescribed forms)** within a non-extendible period of five (5) calendar days from the receipt of the notice from the Bids and Awards Committee that it submitted the Single/Lowest Calculated Calculation.¹

TERMS AND CONDITIONS

- Bidders shall provide the correct and accurate information required in this form.
- Price quotation/s must be valid for a period of sixty (60) calendar days from the date of submission of quotation and/or until the implementation of the program.
- Price quotation/s, to be denominated in Philippine peso shall include all taxes, duties, and/or levies payable.
- Quotations exceeded the Approved Budget for the Contract shall be rejected.
- Bidders must have a physical store with readily available supplies in case in need of post-qualification evaluation.
- Products covered by the Bureau of Philippine Standards' (BPS) mandatory product certification schemes, whether locally manufactured or imported, are required to bear the Philippine Standard (PS) mark or Import Commodity Clearance (ICC).
- Award of the contract shall be made to the lowest calculated and responsive quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.
- Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- The item/s shall be delivered according to the requirements specified in the Technical Specifications.
- The Department of Education - Schools Division of Digos City shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.
- In case two or more bidders are determined to have submitted the Lowest Calculated Quotation/Lowest Calculated and Responsive Quotation, the DepEd - Digos City Division shall adopt and employ "draw lots" as the tie-breaking method to finally determine the single winning provider in accordance with GPPB Circular 009, s. 2016.
- Payment shall be processed after delivery and upon the submission of the required supporting documents, in accordance with existing government accounting rules and regulations. Please note that the corresponding bank transfer fee, if any, shall be charged to the contractor's account.
- Payment shall be made promptly, but in no case later than sixty (60) days, through Land Bank's LDDAP-ADA/Bank Transfer facility after submission of billing statement/invoice and upon fulfillment of other obligations as stipulated in the contract as well as upon inspection and acceptance of the goods by the end user, subject to other payment terms as prescribed in this RFQ.

14. Liquidated damages equivalent to one-tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. The DepEd - Digos City Division may rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

3. Price quotations to be submitted in Philippine pesos and are subject to change without notice.

4. Quotations exceeding the approved budget for the project shall be rejected.

5. Bidders must have a physical store with a verifiable address in the Philippines.

6. Products covered by the Bureau of Philippine Standards (BPS) are subject to inspection and certification by the Bureau of Philippine Standards (BPS) prior to importation.

7. Award of the contract shall be made to the lowest bidder who has submitted the lowest and most complete bid, provided that the bidder complies with the minimum technical specifications and other conditions of the contract.

8. Any modification or amendment shall be valid only if it is signed by the authorized representative of the Department of Education.

9. The terms shall be delivered according to the requirements specified in the bid.

10. The Department of Education - Schools Division Office (SDO) shall have the right to accept or reject any or all bids without obligation to give reasons therefor.

11. In case two or more bidders are determined to have submitted the lowest bid, the SDO shall conduct a random drawing to determine the winning bidder.

12. The contract shall be processed after delivery and upon the submission of the required documents and other conditions of the contract.

13. Payment shall be made promptly, but not later than thirty (30) calendar days from the date of submission of the invoice and other documents required for the contract.
