

OF THE 2025 REGULAR PHILIPPINE EDUCATIONAL
PLACEMENT TEST (PEPT)**

Date : November 11, 2025

Pursuant to DepEd Memorandum No. 098, s. 2025, the Schools Division of Digos City announces the conduct of the **2025 Regular Philippine Educational Placement Test (PEPT)** scheduled for **December 2025**. This assessment is intended for learners in special circumstances to validate grade-level competencies and facilitate appropriate placement in the formal education system.

I. Salient Points

1. Target Registrants:

- Learners from schools without government permits
- Learners from nonformal/informal education programs
- Learners with incomplete or no formal schooling records
- Learners with back subjects
- Learners needing grade-level standards assessment
- Learners overage for their grade level

2. Registration Period:

- Registration shall be open from the date of issuance of this memorandum until **one week prior to the scheduled test administration**. The final date of the examination will be announced through a separate issuance.

3. Testing Center:

- **Digos City High School (DiCNHS)** is the designated testing center for the division.

4. Slot Allocation:

- The Division of Digos City has been allocated **only 15 slots** for PEPT registrants.

- **Acceptance is on a first come, first serve basis**, subject to **complete submission of documentary requirements**.
- 5. **Submission Venue:**
 - All complete requirements must be submitted to the **Records Section of the Division Office**.
- 6. **No Walk-In Policy:**
 - Strictly no walk-in applicants will be accommodated on the day of the test.

II. Registration Requirements

For New Test-Takers:

- Original and photocopy of PSA/NSO or Local Civil Registrar-issued birth certificate
- Certified true copy of school records (SF10/Form 137) with dry seal
- Certificate of attendance in intervention programs (if applicable)
- Two identical 1x1 colored ID photos with name tag
- Accomplished PEPT Registration Form

For Retakers and PEPT Passers:

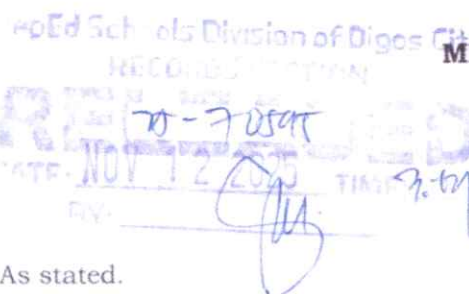
- Original and photocopy of PEPT Certificate of Rating
- Two identical 1x1 colored ID photos with name tag
- Accomplished PEPT Registration Form

III. Additional Notes

- No registration fee shall be collected.
- Examinees who fail one subject may retake the subtest within six months; those who fail two or more subjects must retake all.
- A Certificate of Rating (COR) will be issued to each test-taker.
- Details of the virtual orientation for testing personnel will be announced in a separate advisory.
