Subject: **REORGANIZATION OF MUNICIPAL AND AREA SCOUTING COMMITTEES**

1. All District Scout Commissioners and District BSP Coordinators are hereby requested to conduct reorganization and election of officers who will compose the Municipal Scouting Committee, viz: Municipal Scouting Committee Chairperson, Vice Chairperson, Secretary, Treasurer, and Auditor. The election is preferred to be held on or before **February 15, 2026**.
2. As such, all concerned are advised to convene all Institutional Heads and School BSP Coordinators representing all Sponsoring Institutions within their Municipality to nominate and elect individuals who will potentially support Scouting within your jurisdiction. These individuals should be of legal age, a resident or has business within your jurisdiction including but not limited to public officials, government employees, businessmen, or private stakeholders who are willing to take active part in the Scouting Movement and must possess **CAWIT** (Commitment, Availability, Willingness, Interest, Time).

It should be noted that No DepEd Personnel may be nominated and elected to these positions.

3. After such election, all elected Municipal Chairpersons within their respective areas shall convene and elect and/or choose among themselves an Area Scouting Committee Chairperson who will represent their Area to the Local Council Executive Board. Likewise, areas which only compose of one (1) Municipal Chairman is automatically chosen as the Area Chairperson.
4. Results of the election for the Area Scouting Committee must be submitted to the Council Office on or before **February 28, 2026**.
5. For information, guidance, compliance, and widest dissemination of all concerned.
