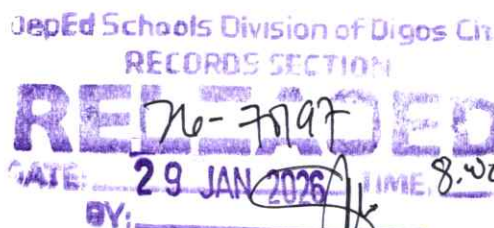
Please be guided of the following:

1. Only qualified individuals who meet the criteria set by the BSP for Regular Membership and Private Sector Representation may be nominated.
2. Nominees for Regular Membership shall not be concurrently nominated as Private Sector Representatives, and vice versa, in accordance with BSP rules to ensure a fair and orderly nomination process.
3. All nominations must be duly endorsed and supported with complete documentary requirements, as prescribed by the BSP Council and be submitted to the **Committee on Nominations and Election (NOMELEC)** of the BSP Davao del Sur–Occidental Council **on or before January 31, 2026**, through proper channels.

All other details, qualifications, and procedures are provided in the attached BSP Council Office Memorandum for ready reference.

Subject: **SUBMISSION OF NOMINEES FOR REGULAR MEMBERSHIP (2025-2028) AND PRIVATE SECTOR REPRESENTATIVES (2025-2026) IN THE LOCAL COUNCIL EXECUTIVE BOARD**

1. The Boy Scouts of the Philippines - Davao del Sur-Occidental Council is pleased to announce the start of the nomination submission process for individuals aspiring to become Regular Members and Private Sector Representatives in the Local Council Executive Board of the Davao del Sur Council, BSP.
2. As stipulated in the Boy Scouts of the Philippines Standard Local Council Constitution and Bylaws, Article V, Section 13 and Article VIII, Section 24(c), the following are specifically provided for:

Article V, Section 13. Committee on Nominations. At least thirty (30) days before the date of the Annual Council Meeting, the Council Chairman shall appoint at least three (3) members of the Council to make nominations at the annual meeting of the Council, subject to the approval of the Executive Board. This committee shall further prepare the nominations for the additional members of the Executive Board and the ensuing election of the officers, both of which are to be elected by the Council Executive Board. Only persons thus nominated by the Committee on Nominations shall be voted upon at the annual council meeting. All elections shall be by ballot and voting by proxy shall not be permitted.

Council members in good standing may submit nominees for the members of the Executive Board. From this and the additional nominees that the Nominations Committee may make, the committee shall prepare a nominations list which shall be not less than twice nor more than thrice the number of positions to be filled.

Article VIII, Section 24(c). Private Sector Representatives. There shall be from five (5) to ten (10) representatives from the private sector to be elected by the newly elected Board to serve for a one-year term immediately following the Council Meeting.

3. The following individuals are qualified to recommend nominees for any position in the Local Council Executive Board:
  - a. Council Officers, Local Council Executive Board Members, and other Council Members in Good Standing;
  - b. District Chairpersons and Commissioners;
  - c. Institutional Heads for Elementary and Secondary Schools (Private and Public).
4. Criteria for Nomination for the Local Council Executive Board, as follows:
  - 4.1 Nominees for Regular Members
    - a. Register with the Boy Scouts of the Philippines - Davao del Sur-Occidental Council.
    - b. Have no ongoing legal cases or actions that could harm the reputation of the BSP or the Local Council.
    - c. Must be residing or have business within the Provinces of Davao del Sur and Davao Occidental.
    - d. Maintain good moral standing in the community.
    - e. Subscribe to and uphold the Scout Oath and Law.
    - f. Be interested in and open to Scouting training.
    - g. Make him/herself available to serve the Movement.
    - h. Maintain good health for effective performance of responsibilities.
    - i. Understand that Board Membership entails responsibility for quorum and decision quality at meetings.



#### 4.2 Nominees for Private Sector Representatives

- a. Be endorsed and nominated by the sector being represented.
  - b. Maintain good moral standing in the community.
  - c. Must be residing or have business within the Provinces of Davao del Sur and Davao Occidental.
  - d. Have a youthful outlook and be recognized in the community as an expert in one of the specified fields (Academe, Business, Finance, Education, Legal, Civic, Barangay, Media, Labor, Religion).
  - e. Subscribe to and uphold the Scout Oath and Law.
  - f. Be interested in and open to Scouting training.
  - g. Make him/herself available to serve the Movement.
  - h. Maintain good health for effective performance of responsibilities.
  - i. Understand that Board Membership entails responsibility for quorum and decision quality at meetings.
5. It is important to note that individuals nominated for the position of Regular Members of the Board are ineligible to be concurrently nominated as Sectoral Representatives. Similarly, nominees vying for the position of Ten (10) Sectoral Representatives are precluded from simultaneous nomination for Regular Membership during the same election. Your attention to this stipulation ensures a fair and equitable election process.
6. Nominations for Regular Membership and Private Sector Representatives in the Local Council Executive Board must be submitted to the Committee on Nominations and Election, c/o Rezeile Anthony V. Donga, Council Scout Executive, BSP Compound, Quirino Ave., Zone I, Digos City, Davao del Sur not later than **January 31, 2026**.
7. Once all forms have been collected following the designated deadline, the Nominations and Elections Committee (NOMELEC) will proceed to prepare an official list of nominees.
