Anent to this, this Office interposes no objection to the invitation of Sinulog Foundation, Inc. provided the following conditions are met:

1. Students' participation in the said activity shall be voluntary and subject to compliance with the non-disruption of classes policy as stipulated in DepEd Order No. 9, s. 2005, titled Instituting Measures to Increase Time-on-Task and Ensuring Compliance Therewith.
2. All learners involved shall submit parent's consent prior to the said activity and protocol on ensuring the safety of all involved, especially of the learners, is in place.
3. The teacher-chaperons shall adhere to the policy on "No Disruption of Classes" as per DepEd Order No. 9, s. 2005. The school head is expected to make necessary arrangements ensuring that classes handled by concerned teachers will be taken care of by another teacher.


4. The school head shall also be guided with DepEd Order No. 66, s. 2017, re: Implementing Guidelines on the Conduct of Off-Campus Activities.


We formally invite the Digos City NHS Marching Band to participate in the competition during the Sinulog sa Kabataan sa Dakbayan on January 10, 2026.
