

This has reference to the issuance of Executive Order No. 5, series 2026 issued by the City Mayor of Digos City on February 5, 2026 titled: ***“AN ORDER SUSPENDING FACT-TO-FACE CLASSES AND DIRECTING THE IMPLEMENTATION OF MODULAR AND BLENDED MODALITIES IN ALL ACADEMIC INSTITUTION IN DIGOS CITY, EFFECTIVE FEBRUARY 5, 2026 AT 1:00 P.M. EXECUTIVE ORDER NO. 05

Series of 2026

"AN ORDER SUSPENDING FACE-TO-FACE CLASSES AND DIRECTING THE IMPLEMENTATION OF MODULAR AND BLENDED LEARNING MODALITIES IN ALL ACADEMIC INSTITUTIONS IN DIGOS CITY, EFFECTIVE FEBRUARY 5, 2026 AT 1:00 P.M., DUE TO TROPICAL CYCLONE WIND SIGNAL NO. 1"

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates local government units to promote the general welfare and ensure the safety of their constituents;

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), in its Tropical Cyclone Bulletin No. 8, reported that Tropical Storm "BASYANG" continues to affect portions of Northern Mindanao, including Davao del Sur, bringing strong winds and moderate to heavy rainfall;

WHEREAS, pursuant to said Tropical Cyclone Bulletin No. 8, PAGASA has placed Davao del Sur under Tropical Cyclone Wind Signal No. 1, which poses potential risks such as flooding, landslides, and other weather-related hazards that may endanger students, teachers, and school personnel;

WHEREAS, the City Government of Digos finds it necessary to suspend face-to-face classes and adopt Modular and Blended Learning Modalities to ensure the safety of learners while maintaining the continuity of educational services during the prevailing adverse weather conditions brought about by Tropical Storm "BASYANG";

NOW, THEREFORE, I, JOSEF F CAGAS, Mayor, **City of Digos**, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Face-to-face classes in all levels in both public and private academic institutions in Digos City are hereby suspended effective **February 5, 2026, at 1:00 P.M.**, until this Executive Order is officially lifted.

SECTION 2. During the period of suspension, all academic institutions are hereby directed to implement Modular and/or Blended Learning Modalities, as applicable, to ensure the continuous delivery of educational services.

SECTION 3. Teachers and non-teaching personnel in public academic institutions shall not be required to report for work during the period of suspension. They are encouraged to coordinate with their respective school heads regarding any alternative work arrangements, subject to safety considerations and existing education guidelines.


Private academic institutions are hereby granted discretion to determine appropriate work arrangements for their teaching and non-teaching personnel.

SECTION 4. School heads and administrators are authorized to determine appropriate learning and work arrangements, including the distribution and retrieval of learning modules, alternative learning activities, and staff deployment, consistent with existing education and civil service rules.


SECTION 5. All concerned offices and school administrators are directed to immediately disseminate this Order and ensure strict compliance.

This Executive Order shall take effect immediately and shall remain in force unless sooner lifted or modified by the undersigned.
