Date : 20 February 2026

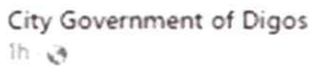
1. This has reference to reported suspension of classes due to bad weather conditions posted in the Facebook Page of the City Government of Digos in which the Executive Order will be issued later.
