The Tournament Managers/trainers and coaches of the athletes shall facilitate the conduct of the different events. The student-athletes shall submit parents' consent to their coaches.

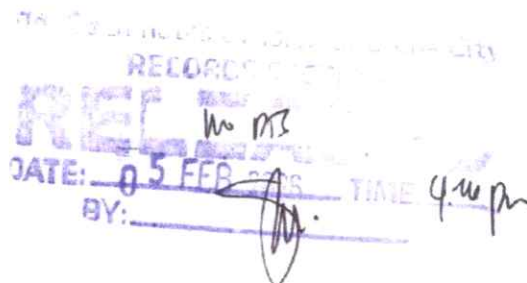
