**MONTHLY VIRTUAL CONVERGENCE OF LEARNER RIGHTS AND PROTECTION
(LRP) FOCAL PERSONS AND ALTERNATE FOCAL PERSONS**

To: Schools Division Superintendents

1. Pursuant to DepEd Order No. 40, s. 2012 (DepEd Child Protection Policy), which mandates the Department to implement zero tolerance against any form of child abuse and to ensure the continuous monitoring of child protection cases, this Office shall conduct a Monthly Online Meeting for all Division Learner Rights and Protection (LRP) Focal Persons and Alternate Focal Persons.
2. To ensure consistent coordination and timely intervention, the meeting shall be held every 4th Monday of every month from 10:00 o'clock in the morning to 12:00 noon via a virtual platform. The meeting link shall be disseminated through official communication channels at least three days prior to the schedule.
3. The meeting shall focus on the following core agenda:
 - a. Status of Reported LRP Concerns (Case management and resolution updates);
 - b. CPC Functionality Updates;
 - c. Budget Utilization Rate (Financial tracking and expenditure reports);
 - d. PPAs Implementation Review;
 - e. Workplace Application Plan (WAP) Implementation and Monitoring; and
 - f. Program Updates and Ways Forward.
4. Focal Persons and Alternate Focal Persons are expected to attend and prepare a status report relative to the agenda for their respective divisions.
5. Immediate and wide dissemination of this Memorandum is desired.
