DESIGNATION OF THE QUALITY ASSURANCE DIVISION (QAD)  
AS FOCAL DIVISION FOR THE IMPLEMENTATION OF THE  
SENIOR HIGH SCHOOL VOUCHER PROGRAM

To: Assistant Regional Director

Chief Education Supervisors of the RO Functional Divisions

1. The Quality Assurance Division (QAD) is designated as the focal Division to spearhead the implementation of the policies enumerated in **DepEd Order No. 20, s. 2023 (Guidelines on the implementation of the Senior High School Voucher Program -SHS VP)**.

2. Pursuant to **item XX (d) of DO 20, s. 2023**, the QAD shall have the following responsibilities:

- a. coordinate with the Government Assistance and Subsidies Office (GASO) at the DepED Central Office, Private Education Assistance Committee National Secretariat (PEAC NS), Private Education Assistance Committee National Secretariat Regional Secretariat (PEAC RS) on the implementation of the SHS Voucher Program, including the conduct of regional orientations;
- b. check and validate the submitted billing statements;
- c. assist the Regional Director during the Regional Program Committee assemblies, meetings or monitoring activities; and
- d. establish a mechanism for promoting the GAS programs particularly the SHS VP.

3. Attendant to the aforementioned tasks, the Quality Assurance Division is also required to conduct monitoring and evaluation activities and document reviews to VP participating SHS relative to their compliance to the SHS VP.
