



4. The ROSC shall assist the ROPDC in the conduct of selection process and shall perform the following duties and responsibilities:

a. Conduct review and judiciously screen the endorsed scholarship application/nomination from SDOs and RO functional divisions based on the standard criteria set forth by DepEd and the sponsoring agencies;

b. Conduct behavioral-event interview to assess the applicant's abilities in relation to the required competencies in the scholarship program to be filled, and

c. Submit the comparative assessment of the nominees for the scholarship grants to the ROPDC for recommendation and subsequent endorsement by the Regional Director to the Central Office, and, or to the sponsoring agencies where applicable.

5. Immediate dissemination of and strict compliance with the provisions of this Memorandum are hereby directed.
