DepEd officials and personnel who are not part of the official delegates may attend the 2026 NFOT on official business and at the discretion of the head of office relative to Memorandum Circular No. 114 of the Office of the President, titled "Directing All Government Agencies and Instrumentalities to Strictly Adopt Energy Conservation Protocols."
