Subject: **EMERGENCY SERVICE TRAINING COURSE (ESTC)**

1. The Boy Scouts of the Philippines – Davao del Sur Council is pleased to announce the conduct of the Emergency Service Training Course on **May 11-16, 2026** with the venue to be announced later.
2. A Registration Fee of **P1,200.00** shall be collected from each participant to cover the expenses incurred during the training which includes handouts, materials, ESC Neckerchief, t-shirt, and other administrative expenses.
3. Participant must be currently registered as a Senior Scout with the Boy Scouts of the Philippines, must be physically and mentally fit, must possess good moral character, must be **AT LEAST 14 ½ YEARS OLD** or was born on or before November 11, 2011, must have **ATTENDED** and **PASSED** the **CREW LEADERS TRAINING COURSE**, and must have **TAKEN** and **PASSED** the **PRE-QUALIFYING TEST**.

Adult Leaders interested in participating must be currently registered as a Unit Leader with the Boy Scouts of the Philippines, must be physically and mentally fit, must possess good moral character, and must have at least attended and passed any Basic Training Course for Unit Leaders.

4. **PRE-QUALIFYING TEST.** All aspiring ESTC participants must take and undergo the Pre-Qualifying Test on **April 10, 2026 (Friday)** which will start at exactly **7:00 AM** at the BSP Council Office, Quirino Ave., Digos City.
5. All qualified participants are hereby advised to report at the training venue on or before **1:00 PM** on May 11, 2026.
6. Qualified participants are also advised to bring the following items, to wit: Type "A" Scout Uniform (REQUIRED); Tent, Sportswear with rubber shoes and personal gears/beddings; eating & cooking utensils; Duly filled-up application form with parent's consent and medical certificate; and **FOOD PROVISION** sufficient for the whole duration of the training.
7. Corresponding compensatory overtime and/or service credits shall be granted to all participating and serving Adult Leaders as provided for by DepEd Order No. 76, s. 2012.
8. For information, guidance, compliance, and widest dissemination of all concerned.
