Relative to the 2026 National Festival of Talents (NFOT), in Roxas City on April 18-22, 2026, this Office informs the conduct of the Regional Cliniquing Sessions and Final Coaching for Qualifiers of SPFL-Related Events in the 2026 FOT, from 8:00 AM to 5:00 PM on April 10, 2026, at Durian Hall, DepEd Regional Office XI, F. Torres St., Davao City.

The activity aims to:

- present the plans and approaches of coaches for each SPFL-related event;
- discuss effective collaborative strategies in the three (3) SPFL-related events in the NFOT;
- provide tips and techniques in handling the introduction of outputs and final presentations in CineMunti, Likhawitan, and Savor D' Flavor;
- critique the simulated presentation of the qualifiers; and
- guide the participants on the security and safety protocols in official travels.

The SPFL Education Program Supervisors, NOT learner-qualifiers, coaches, and select SPFL-Korean and Chinese Mandarin teacher-experts are the participants in the activity.

Service credits will be granted to teacher-participants in accordance with DepEd Order No. 53, s. 2023, Updated Guidelines on Grant of Vacation Service Credits to Teachers, and CSC-DBM Joint Circular No. 2, s. 2015, Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees. The activity matrix and other important details are in the enclosures.

The transportation, meals, and/or other incidental expenses of the participants shall be chargeable against MOOE/Local Funds, subject to usual accounting and auditing procedures.
