In reference to Regional Memorandum CLMD-2026-222 dated June 1, 2026, titled "Reiteration of DepEd Order No. 47, s. 2016 Re: ECCD Checklist in Booklet Type for Kindergarten Learners," this Office directs all public elementary schools offering Kindergarten to ensure the provision, proper use, and safekeeping of the ECCD Checklist in booklet form for every Kindergarten learner.

The ECCD Checklist shall be used by Kindergarten teachers as an ongoing and developmentally appropriate assessment tool to establish individual learner profiles, identify developmental needs, monitor learner progress across developmental domains, guide instruction, and support early intervention.

The booklet shall be accomplished by the Kindergarten teacher, kept with confidentiality, and used as basis for monitoring learner progress. At the end of the school year, the accomplished ECCD Checklist booklet shall be properly turned over to the receiving Grade 1 teacher, together with other relevant learner records, to ensure continuity of support and instruction.

School Heads shall ensure the reproduction, distribution, safekeeping, and proper turnover of the ECCD Checklist booklet. The ECCD Checklist shall be reproduced in booklet type using sturdy paper to ensure durability and continued use throughout the school year. The booklet shall serve as the individual developmental record of the learner. School Heads shall also monitor its proper accomplishment by the assigned Kindergarten teachers.

Expenses relative to the reproduction of the ECCD Checklist booklet may be charged against local school funds or other available funds, subject to the usual accounting and auditing rules and regulations.

Immediate dissemination of and strict compliance with this Memorandum are directed.

REITERATION OF DEPED ORDER NO. 47, S. 2016 RE: ECCD CHECKLIST IN

This is pursuant to DepEd Order No. 47, s. 2016, otherwise known as the *Omnibus Policy on Kindergarten Education*, which provides that assessment in Kindergarten shall be ongoing, developmentally appropriate, and used to establish individual learner profiles, identify developmental needs, guide instruction, and support early intervention. This Office, through the Curriculum and Learning Management Division, directs all public elementary schools offering Kindergarten to provide each Kindergarten learner with an ECCD Checklist in booklet form.
2. The booklet shall be accomplished by the Kindergarten teacher, kept with confidentiality, and used as basis for monitoring learner progress across developmental domains. At the end of the school year, the accomplished ECCD Checklist booklet shall be turned over to the receiving Grade 1 teacher, together with other relevant learner records, to ensure continuity of support and instruction.
3. The ECCD Checklist shall be reproduced in booklet type using sturdy paper to ensure durability, proper safekeeping, and continued use throughout the school year. The booklet shall serve as the individual developmental record of the learner.
4. School Heads shall ensure the reproduction, distribution, safekeeping, and proper turnover of the ECCD Checklist booklet. Expenses may be charged against local school funds or other available funds, subject to the usual accounting and auditing rules and regulations.
5. Immediate dissemination of and strict compliance with this Memorandum are directed.
