The meals and snacks will be shouldered by the WMCI.

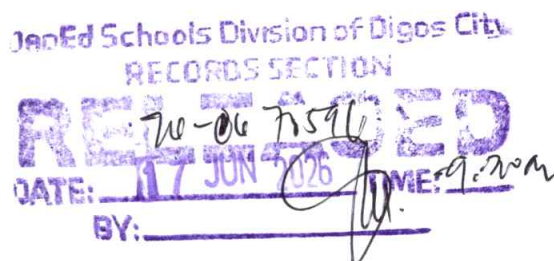
Travelling, and other incidental expenses of the participant shall be charged to the Division MOOE or local funds, all subject to the usual government accounting and auditing rules and regulations.
