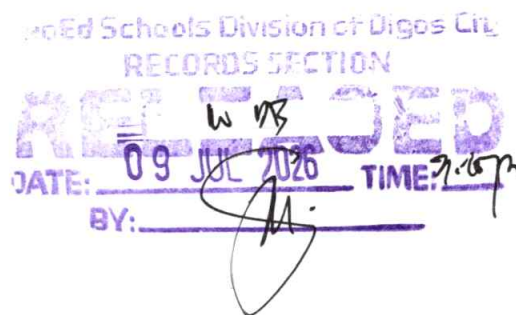
- Personnel of the Department of Education),” and other applicable travel-related policies and guidelines;*
2. Prior coordination with the immediate Unit Head and approval of the Schools Division Superintendent;
 3. Participation shall not disrupt or affect the regular duties and responsibilities of the personnel concerned; and
 4. Utilization of DepEd funds shall strictly adhere to standard budgeting, accounting, and auditing rules and regulations.

Registration fees, travel, meals, and other incidental expenses incurred in relation to the activity shall be charged to the respective local funds—School MOOE for school-based personnel and SDO funds for Division Office personnel—subject to the usual accounting and auditing procedures.
