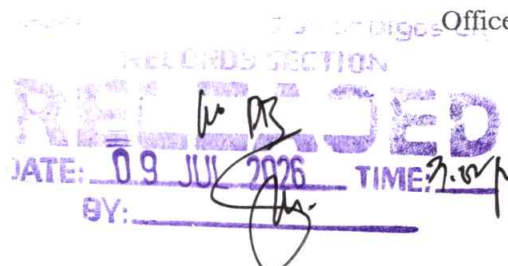

In view thereof, this Office respectfully informs your Office that a Simultaneous Exercise (SIMEX) will be conducted from time to time on various dates within or in the vicinity of schools in Digos City. This activity aims to enhance the preparedness and response capabilities of PNP personnel in addressing incidents that may compromise the safety and security of students within the city. The exercise will simulate various emergency scenarios, as follows:

1. Unattended Baggage;
2. Active Shooting (Alarm 166);
3. Motornapping;
4. Robbery Hold-up;
5. Stabbing Incidents (Alarm 155);
6. Hostage Taking;
7. Bomb Threat;
8. Ongoing Domestic Violence;
9. Person Running Amok; and
10. Riot (Gang War)/Public Disturbances.
