SUBJECT: **REDUCTION OF SCOUT MEMBERSHIP FEE FROM ₱65.00 TO ₱60.00**

Date : August 19, 2026

In reference to Boy Scouts of the Philippines (BSP) Davao del Sur-Occidental Council Office Memorandum No. 21, s. 2026, dated August 4, 2026, the field is informed of the reduction of the Scout Membership Fee from Sixty-Five Pesos (₱65.00) to Sixty Pesos (₱60.00) per registered Scout.

The reduction resulted from the discontinuance of the Five-Peso (₱5.00) Membership Share, previously allocated as follows: ₱3.00 School Share, ₱1.00 District Share, and ₱1.00 Council Share.

The revised membership fee of ₱60.00 per registered Scout shall take effect retroactively on August 1, 2026, and shall apply to all membership registrations processed on or after said date across all Scouting units, namely KID, KAB, Boy, Senior, and Rover Scouts. No unit leader, coordinator, or other personnel concerned shall collect any additional amount beyond the prescribed ₱60.00 membership fee.

Schools may, however, opt to collect an additional amount for their Institutional Scouting Fund, provided that such collection is separate and independent from the official BSP Council membership fee and is duly authorized by the School and Parent-Teacher Association (PTA), with proper internal accounting and institutional consensus.

Further, all unclaimed prior School and District Shares currently held by the Council may be claimed subject to the following requirements:

- School Share – ₱3.00 per Scout: To be claimed by the School BSP Coordinator upon submission of an Authorization Letter duly signed by the School PTA President and School PTA Treasurer; and
- District Share – ₱1.00 per Scout: To be claimed by the District BSP Coordinator upon submission of an Authorization Letter duly signed by the Public Schools District Supervisor (PSDS).

School Heads and BSP Coordinators are directed to properly inform all concerned personnel, parents, guardians, and Scout members of the revised membership fee and to ensure strict compliance with the foregoing provisions.

Immediate and widest dissemination of this Memorandum is desired.

District BSP Coordinators, High School BSP Coordinators, Unit Leaders

Subject: REDUCTION OF SCOUT MEMBERSHIP FEE FROM P65.00 TO P60.00

1. Upon consultation with the BSP Coordinators and upon full review which was formally presented, deliberated, and approved during the Executive Committee Meeting last July 27, 2026. The Boy Scouts of the Philippines, Davao del Sur-Occidental Council hereby announces the adjustment and reduction of the **Membership Fee for Scouts** from Sixty-Five Pesos (P65.00) to **Sixty Pesos (P60.00)** per registered Scout.
2. The fee reduction is primarily due to the discontinuance of collecting the Membership Share amounting to Five Pesos (P5.00), which was previously earmarked and allocated as follows: School Share at P3.00 per Scout; District Share at P1.00 per Scout; and Council Share at P1.00 per Scout.
3. This fee reduction shall **take effect retroactively on August 1, 2026**. All membership registrations processed on or after this date must observe the revised fee across all units (KID, KAB, Boy, Senior, and Rover Scouts). No unit leader or coordinator shall collect additional amounts beyond the approved P60.00 rate per Scout.
4. Schools may, however, opt to collect an additional fee for their institutional Scouting Fund. This collection shall be entirely independent of the official Council membership fee, subject to proper School and Parent-Teacher Association (PTA) authorization, internal accounting, and institutional consensus.
5. All unclaimed prior school and district shares currently held by the Council are advised to be claimed following these specific authorization requirements:
 - School Share (P3.00/Scout): Must be claimed by the School BSP Coordinator, supported by an Authorization Letter duly signed by the School PTA President and School PTA Treasurer.
 - District Share (P1.00/Scout): Must be claimed by the District BSP Coordinator, supported by an Authorization Letter duly signed by the Public Schools District Supervisor (PSDS).
6. For immediate information and widest dissemination to all concerned.
