# CONTRACT

This AGREEMENT, made this \_\_\_\_day of 0 5 SEP 2063 \_\_\_, 2023 at Digos City, Province of Davao del Sur by and between:

**DEPARTMENT OF EDUCATION – SCHOOLS DIVISION OF DIGOS CITY** represented by **Melanie P. Estacio, PhD, CESO VI**, OIC-Schools Division Superintendent, with office address at Roxas corner Lopez-Jaena Streets, Barangay Zone II, Digos City, Davao del Sur, hereinafter called "the Entity",

and

**D'PARAGON AA CORP** represented by **JEFREE M. GUINAWATAN**, Authorized Representative, with business address located at Prk 24, Malagamot, Barangay Panacan, Davao City, Philippines hereinafter called "the Supplier";

WHEREAS, the Entity invited Bids for certain goods, particularly Project No. 23-06-069: Procurement of Food Supplies for the Implementation of School-Based Feeding Program for SY 2023-2024 (Lot 3: Procurement of Fortified Rice) and has accepted a Bid by the Supplier for the supply of those goods in the sum of One Million Ninety-Nine Thousand Six Hundred Twenty-Eight Pesos (Php 1,099,628.00) hereinafter called "the Contract Price".

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - Philippine Bidding Documents (PBDs);
    - Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of One Million Ninety-Nine Thousand Six Hundred Twenty-Eight Pesos (Php 1,099,628.00) or such other sums as may be ascertained, D'PARAGON AA CORP. agrees to deliver Food Supplies for the Implementation of School-Based Feeding Program for SY 2023-2024 (Lot 3: Procurement of Fortified Rice) in accordance with its Bid.
  - 3.1. The price specified above is inclusive of all other charges including payment for taxes, duties, levies and charges assessed on it in connection with this Contract.
- The Department of Education Schools Division of Digos City agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- Delivery
  - 5.1. The Supplier hereby covenants to deliver said *Food Supplies* on the Eight (8) Elementary Schools under the Schools Division of Digos City as drop-off points with the duration of **85 days (once every week)**. Cost of delivery is deemed included in the price specified above;
  - 5.2. Delivery shall commence on 18 SEP 203 and will be every Monday of the week from 8:00 AM to 11:00 AM.
  - 5.3. Bread received must be in good condition, not expired, no signs of molds, no foul smell, and in soft textures. Individually packed in food grade plastic pouches or 1 pouch for the number of feeding days. The Packaging must clearly and readably indicate the Manufacturing Date and the Expiration Date. If possible, there must be an imprinted sign per pack which indicates "DepEd-SBFP, NOT FOR SALE". Price inclusive of delivery fare. PLEASE refer to the Revised Specifications for NFP attached to the Menu.
  - 5.4. Delivery to school placed in bread crates and delivered in a closed transportation (van).
  - 5.5. Personnel involved in the production of commodity should wear the proper protective equipment like apron, hairnet, and disposable plastic food gloves.
  - 5.6. Delivery personnel will wear PPE like hairnet, white clean shirt, and shoes.

In case of failure to deliver the said goods within the stipulated period, the Supplier shall be liable to the Entity for Liquidated Damages equivalent to at least one tenth (1/10) of one percent (1%) of the value of the unperformed portion of the contract every day of delay or breach of the delivery schedule by the Supplier. The Supplier, however, may request that the period be extended on valid and reasonable grounds, subject to the Entity's approval. If so, the Supplier shall give a written notice at least one (1) week ahead of the schedule.

### 6. Inspection and Acceptance

- 6.1. The Entity or its representative shall have the right to inspect and/or test the goods at the delivery address and the Supplier shall facilitate such inspection and provide required assistance;
- 6.2. The Entity shall have fifteen (15) days after proper receipt of the goods purchased to inspect them and either accept or reject them as non-conforming with this Contract. All rejected goods will be returned to the Supplier at the latter's expense. The Entity's right to reject the Goods shall not be limited or waived by the Goods having been previously inspected or tested by the Entity prior to delivery;
- 6.3 The Supplier agrees that the Entity's payment under this Contract shall not be deemed acceptance of any Goods delivered hereunder.
- 6.4. The Supplier agrees that any acceptance by the Entity does not release the Supplier form any warranty or other obligation under this Contract;
- 6.5. Title to the Goods shall pass to the Buyer when they are delivered and accepted by the Entity. Risk of loss, injury, or destruction of the Goods shall be borne by the Supplier until title passes to the Entity.
